

Reverse Raffle Official Rules

Unlike a typical raffle, in a Reverse Raffle the purchaser of the last ticket drawn wins the Grand Prize. Proceeds go to the Highlands Little Theatre general fund.

- 1. By entering this raffle, entrants accept and agree (1) to be bound by all the rules, limitations and restrictions set forth here and (2) that their names and/or likenesses may be disclosed to and used by the news media and may otherwise be used by HLT for publicity purposes and in lists of prize winners to be published in area newspapers and announced on the HLT website. Other rules and regulations may apply. Please contact HLT if you have questions.
- 2.Up to \$6015 in Prizes will be awarded during the raffle period 8/21/2020 to 11/8/2020. Funds for consolation prizes will come from raffle ticket sales.
- 3. The raffle is open to the public.
- 4. Reverse Raffle Tickets are \$50.00 each + applicable online processing fees. Check with your tax advisor to determine if this donation is tax deductible.
- 5. You must be 18 years or older to purchase a Ticket.
- 6.A **maximum of 250** tickets will be sold.
- 7. Gross proceeds are defined as the total number of tickets sold at \$50.00 per ticket.
- 8.A Ticket is considered purchased when complete payment (\$50.00 each) has been received and recorded with entrant's name and contact information.
- 9. Ticket sales will end no later than 2:45 pm on Sunday, November 8, 2020.
- 10. Ten Tickets will be drawn **August 21, 22, 23, 26, 28, 29, 30, September 4, 5, 6, 11, 12, October 23, 24, 25, 28, 30, 31, November 1, 4, 6, 7, 8, 2020.** Excepting November 8, five tickets will be drawn before the start of the show and five at intermission. The 1st, 50th, 100th, 150th, 200th, and 245th, tickets drawn will receive a prize. If less than 250 tickets are sold, the number of prizes awarded will be adjusted accordingly. The value of each prize will be determined in advance by the Reverse Raffle Committee. Eliminated tickets will be posted on the HLT Facebook & Instagram accounts, in a weekly newsletter and on our website at www.HighlandsLakesideTheatre.org.
- 11. The final remaining Ticket Holder will receive the Grand Prize of the 2013 Mini Cooper.
- 12. Businesses, companies and non-profit organizations may purchase a ticket, or several people can share the cost of a ticket however one person must be named as the Ticket Owner. The Ticket Owner controls the ticket. If the ticket owner is not present, the Ticket Owner will be contacted after the drawing to claim the prize.
- 13. Ticket Owners need not be present in order to win.
- 14. Prizes will be awarded to the Ticket Owner who is responsible for sharing the proceeds with any other parties.
- 15. Winner agrees that he/she are solely responsible for any and all taxes due on the awards, and all costs connected with transfer of title to the winner. The Prize winner of the Car shall assume all fees, local, state and federal taxes, sales tax, as well as insurance proof of which must be provided prior to delivery. Highlands Little Theatre, Inc. (HLT) takes no responsibility for any tax liabilities or costs. All defective or physically altered raffle tickets will be immediately disqualified by HLT. Prior to the Prize drawing, HLT will make a reasonable effort to notify the individual and/or entity that submits such an entry form or one which has been rejected because the credit card or check did not clear that the entry has been rejected by attempting to make contact through the information provided at the time of submitting the purchase request. All orders for tickets must be received and/or purchased by the indicated deadline. HLT assumes no responsibility for lost, late, misdirected or non-delivered mail or messages, or any other failure to receive orders or deliver receipts prior to the drawing deadlines.
- 18. In order to collect his or her prize, a Raffle ticket winner may be required to sign and deliver to HLT: (a) a sworn affidavit of eligibility in accordance with these Rules and applicable law, including without limitation that he or she is at least 18 years old at the time he or she purchased the winning Raffle ticket; (b) such written information as is required by any applicable tax and/or real estate laws, including without limitation his or her Social Security Number; (c) proof of identity in forms satisfactory to HLT showing that the person claiming the prize is the same person who is named on the winning Raffle ticket; and (d) the winning Raffle ticket confirmation. The Prize winner may be required to submit a W-2G, Form 5754 or similar tax form (provided by HLT) for tax withholding purposes. Prizes not collected by December 31, 2020 will be forfeited and another prize winner will **not** be selected. In that case the car will be sold for the best price and the proceeds deposited into the HLT general use fund.
